THE HOUSEHOLDS HAVE INCOME DERIVED FROM AGRICULTURAL WORK IN THE AMOUNT NOT LESS THAN \$3,050 AND WHO EARN A TOTAL ANNUAL INCOME EQUAL TO OR LESS THAN 50% OF AMI FOR YAKIMA COUNTY, WASHINGTON. THE RENT PAID BY TENANT DOES NOT EXCEED 30% OF THEIR MONTHLY INCOME. THE RENT IS ADJUSTED FOR FAMILY SIZE AND UTILITIES. THERE IS A FULL-TIME MANAGER WHO LIVES ON SITE.
